WHAT IS AMIA?

The American Medical Informatics Association (AMIA) is a community committed to the vision of a world where informatics transforms health care. It's the professional home for the informaticians of today and the driver for the future of informatics.

AMIA's 5,500+ members are subject matter experts in the science and practice of informatics as it relates to clinical care, research, education, and policy. AMIA supports its members and the field through education, training, accreditation, certification, and advocacy and provides extensive opportunities for networking and collaboration.

Individual members include clinical and health informatics professionals (physicians, nurses, dentists, pharmacists, and other clinicians); translational and clinical informatics scientists, researchers, and educators; biomedical and health science librarians; advanced students pursuing a career in informatics; developers, computer, artificial intelligence, and data scientists; government officials and policymakers; consultants and industry professionals.

AMIA's membership also includes industry partners, academic institutions, and **health systems and hospitals**.

AMIA's many online educational programs — the [10x10 Virtual Courses](#), the [AMIA Health Informatics Certification Review Course \(ARC\)](#), the [Clinical Informatics Board Review Course \(CIBRC\)](#), and the new [Health Informatics Essentials](#) courses — are all available through the Health System Membership.

Through the membership, individual health system and hospital employees are granted credits they can use to take advantage of AMIA's digital, learning-on-demand programs. Plus, they receive other value-added benefits to help them engage in the informatics community.

MEMBERSHIP ELIGIBILITY

The Health System Membership is available to organizations that deliver or pay for healthcare or public-health services.

Health systems include integrated delivery networks, hospitals, clinics, provider groups, home health agencies, insurance companies, state/county/city departments of health, government agencies, and healthcare quality-and-safety-promotion organizations. A membership may be held at the corporate, regional, or local level.

MEMBERSHIP BENEFITS

All Health System Members will receive these valuable member benefits.

Educational Credit Allotments

Health System Members receive educational credit allotments, which may be redeemed for AMIA’s online educational offerings by the members’ individual employees, whether they are AMIA members or non-members. The number of included educational credits varies by Health System Membership level.

AMIA Conference Registration

Health System Members receive AMIA conference registrations, which may be redeemed for AMIA Clinical Informatics Conference or AMIA Annual Symposium, to encourage further educational training and networking. The number of included conference registrations varies by Health System Membership level.

Health Systems Council

Health System Members are eligible to appoint a representative to serve on the Health Systems Council and participate in the Health System Council’s virtual monthly meetings and in its face-to-face business meetings held in conjunction with in-person conferences. Council members network, share ideas, discuss issues that affect health systems and hospitals, and weigh in on public policy topics.

AMIA Membership Directory

Health System Members gain access to the AMIA membership directory, which provides individual names, titles, institution names, and other useful contact information.

AMIA Individual Memberships

Health System Members receive AMIA individual memberships to foster engagement in the association. The individual members receive all regular AMIA membership benefits and AMIA’s communications. The number of included individual memberships varies by Health System Membership level.

AMIA Conference Registration Discounts

Health System Members receive non-member early bird rate discounts for Health System member workforce learners to AMIA conference registrations, which may be redeemed for AMIA Clinical Informatics Conference or AMIA Annual Symposium, to encourage further educational training and networking. The number of included conference discounts varies by Health System Membership level.

Public Policy Rapid Response Teams

AMIA convenes a response team of policy experts and institutional members who generate comments on regulation and other public policy matters. AMIA codifies the comments in responses. A Health System Member may also coordinate its own responses with those of AMIA, amplifying the comments from both AMIA and the health system.

10x10 Virtual Courses

AMIA's 10x10 Virtual Course Program utilizes curricular content from certified informatics training programs and other AMIA educational initiatives. Topics range from introductory health informatics courses to more specialized courses focusing on nursing informatics and clinical decision support. These courses are ideal for those looking to advance their health care profession with informatics training.

AMIA Health Informatics Certification Review Course (ARC)

This course helps health informatics professionals prepare to sit for the AMIA Health Informatics Certification (AHIC) exam. The AHIC Review Course (ARC) is a sustained study program with all 40+ hours of AMIA Health Informatics Essentials lectures. Through 119 brief lectures with hundreds of hyperlinked references and resources and several quizzes per unit, ARC will help learners become familiar with the content and types of questions on the AHIC exam. The goal of ARC is to help learners identify gaps in their knowledge that require additional self-study and to think about how they could be tested on the application of knowledge. Through an online forum, ARC will also provide opportunities for learners to interact with each other and the instructors in support of achieving AMIA certification.

Clinical Informatics Board Review Course (CIBRC)

This course provides American Board of Medical Specialties (ABMS) board-certified physicians with resources to assist in becoming certified in the subspecialty of clinical informatics. The course offerings are a resource for all practicing clinical informaticians seeking to strengthen their knowledge of the field. Two options are available:

CIBRC Online Plus

This on-demand, in-depth online course includes 30 hours of online learning content, provided in 23 modules, knowledge check quizzes per module, and 200 exam-style review questions.

CIBRC Bundle

This three-day, intensive course is led by distinguished faculty, who are leaders in Biomedical Informatics and board-certified practicing clinical informaticians combined with CIBRC Online

Health Informatics Essentials

Comprised of five separate courses, AMIA Health Informatics Essentials offers more than 40 hours of on-demand education. Each CME/CNE-certified course offers topical modules with multiple video lectures, ranging in length from 8 to 30 minutes. With a curriculum based on AMIA's Health Informatics Delineation of Practice published in JAMIA (Gadd et al, 2020), learners access subject matter that is core to the practice of health informatics. The courses are designed for professionals who are involved in direct or indirect care of patients and who desire to learn more about the practice of health informatics coming from a range of educational and training pathways, including but not limited to nursing, medicine, pharmacy, dentistry, public health, health informatics, and computer science. Valued at just one educational credit each, the five available courses are:

Health Informatics Essentials: **Health Information Systems**
